#### **RECOMMENDATION:** That Council:

- B. Provide direction to staff regarding alternative recommendations based on Council's review of the City Administrator's Recommended Budget for Fiscal Year 2024 and 2025 over the last several weeks.

#### DISCUSSION:

On April 18, 2023, the City Administrator filed the Fiscal Year (FY) 2024 Recommended Budget. The FY2024 budget includes a multi-faceted approach to balancing the General Fund Budget, including permanent expenditure reductions and a minimal use of reserves. The General fund is projected to have an operating deficit over the next three fiscal years. In collaboration with department staff and the City Council, staff will develop strategies to achieve fiscal sustainability to ensure we continue to deliver high quality services to the community.

Since the budget was released, the City Council has held seven public hearings during which each City department presented their budget, and the public had the opportunity to provide feedback to City Council. During those budget meetings, Council expressed interest in several items that would have a budgetary impact in FY2024. In addition, the Finance Committee reviewed certain portions of the Recommended Budget in more detail over four meetings.

With the completion of department budget presentations, staff is seeking direction from Council regarding alternative recommendations based on Council's review of the City Administrator's Recommended Budget for FY2024 and FY2025.

On June 7, 2023, the City Council is scheduled to deliberate and provide final direction to staff prior to adoption scheduled for June 13, 2023.

#### **BUDGET/FINANCIAL INFORMATION:**

The General Fund operating budget has a structural deficit of \$3.8 Million in FY2024 and \$8.9 Million in FY2025. To reduce the deficit and use of reserves each year to balance the budget, the City Administrator's Recommended Budget called for expenditure reductions in all General Fund departments. After these reductions were included, the revised deficit in FY2024 decreased to \$1.1 Million, and decreased in FY2025 to \$4.8 Million.

The City Council may choose not to approve of the staff recommended fee and other changes to the Recommended Budget. Fee reductions would likely reduce budgeted revenues; alternatively, fee increases would likely increase budgeted revenues.

The City Council also expressed recommendations to multiple department budgets during budget hearings. If Council chooses not to approve of the expenditure reductions included in the City Administrator's Recommended Budget, then Council can identify alternative reductions to be included. If alternative reductions are not identified and approved, then the General Fund would require additional reserves to pay for budgeted expenditures in both FY2024 and FY2025, further depleting General Fund continency reserves.

On May 16, 2023, the Finance Committee voted unanimously to direct staff to develop a plan to refill reserves during budget deliberations.

The City Council adopted Resolution 22-126 on December 8, 2022, establishing the citywide reserve policy for the General Fund and other funds. The policy establishes a 10% contingency reserve and 15% disaster reserve for the General Fund. According to the Quarter 3 financial report approved by the City Council on May 23, 2023, staff is projecting a General Fund deficit of \$2.7 Million in FY2023, which would result in projected reserves of \$36.9 Million, which is \$5.3 Million lower than the targeted reserves of \$42.2 Million. The City Administrator's Recommended Budget calls for a use of reserves in both FY2024 and FY2025. If Council recommends not approving of the recommended expenditure reductions without identifying alternative expenditure reductions, additional reserves would be required to balance the budget.

Section 4 of the reserve policy describes that any use of the disaster or continency reserves requires a majority vote of approval by the City Council. When the use of reserves is recommended, a justification should include an assessment of the fiscal condition and outlook of the General Fund, a balancing strategy which may include expenditure reductions, revenue enhancements, the use of one-time funds or the use of available reserves, and a plan of replenishment to achieve target reserves.
